

Sherlock Holmes, Cracking the Case Contest

RULES OF PARTICIPATION

1. The *Sherlock Holmes, Cracking the Case Contest* (hereinafter the “Contest”) is organized by Pointe-à-Callière, Montréal’s Archaeology and History Complex (hereinafter “Pointe-à-Callière”). The Contest runs from November 8, 2025 at 10:00 am ET to November 27, 2025 at 11:59 pm ET.

ELIGIBILITY

2. The Contest is open to any person who:
 - a. resides in Québec
 - b. is 18 years of age or older at the time the Contest is held.
3. The following persons are not eligible to participate in the Contest: employees, officers, directors, agents, representatives or mandataries of Pointe-à-Callière—as well as members of their immediate families (father, mother, sister, brother, child), legal or common-law spouses—and all individuals with whom these persons are domiciled.

PARTICIPATION

4. For a chance to win the Contest, participants must correctly complete all fields on the entry form and agree to subscribe to Pointe-à-Callière’s general newsletter.
5. No purchase is necessary to enter the Contest.
6. A limit of one (1) entry per participant will be accepted. Furthermore, only one (1) entry per email address will be accepted.

DESCRIPTION OF THE PRIZE

7. The prize includes the following:
 - a. one (1) double pass for the exhibition *Sherlock Holmes, Cracking the Case* at Pointe-à-Callière, located at 350 Place Royale, Montréal (Québec) H2Y 3Y5.
 - b. a one (1) night stay for two (2) people in a double occupancy room, with breakfast included, at Hotel Saint-Sulpice (Saint-Paul Apartment), located at 414 Saint-Sulpice, Montréal (Québec) H2Y 2V5.
8. The prize does not include the following:
 - a. transportation to the destination.
9. The total value of the prize is \$458.

10. Prize item a., the one (1) double pass for the exhibition *Sherlock Holmes, Cracking the Case*, can be used during the exhibition period, from November 27, 2025 to March 8, 2026.
11. Prize item b., the one (1) night stay for two (2) people, with breakfast included, at Hotel Saint-Sulpice is valid until December 31, 2026 and cannot be used at the following times: on public holidays, on Valentine's Day (February 14, 2026), during F1 Grand Prix week (May 22 to 24, 2026), and during the Osheaga Festival (July 31 to August 2, 2026).
12. The prize cannot be transferred, exchanged, redeemed for cash, or modified.

AWARDING OF THE PRIZE

13. The winner will be determined in a random draw from all eligible entries. The draw will take place online on Monday, December 1, 2025, at 11:00 am.
14. Pointe-à-Callière will contact the winner by email to inform him/her of the results of the Contest draw. The winner must respond within seventy-two (72) hours of this notification to provide proof of age (18 years of age or older), using government-issued identification, and to confirm acceptance of the prize. Failure to do so will automatically result in forfeiture of the Contest prize. In such a case, a new random draw will be held to determine a winner.
15. Pointe-à-Callière will email a certificate confirming the prize to the winning person who has accepted the prize within the allotted time.

USE OF THE PRIZE

16. To use the prize, the winner must make a reservation before arriving at Hotel Saint-Sulpice. The winner will be provided with contact information for a member of the Hotel Saint-Sulpice staff. The winner must then contact this staff member to make the required reservation at Hotel Saint-Sulpice.
17. Prize item a., the one (1) double pass for the exhibition *Sherlock Holmes, Cracking the Case*, can be used from November 27, 2025 to March 8, 2026, subject to available spaces at Pointe-à-Callière. After March 8, 2026, the prize automatically becomes null and void and will be unusable.
18. Prize item b., the one (1) night stay for two (2) people, with breakfast included, at Hotel Saint-Sulpice, can be used until December 31, 2026, subject to availability at Hotel Saint-Sulpice, excluding the periods mentioned in Paragraph 11. After December 31, 2026, the prize automatically becomes null and void and will be unusable.

CONSENT TO THE USE OF PERSONAL INFORMATION

19. Should you win the Contest, you consent to allow Pointe-à-Callière to collect and use your full name and email address to contact you and send you the prize.

However, if you withdraw your consent, Pointe-à-Callière will not be able to deliver the prize, if it has not already been issued, which you acknowledge and accept.
